FINANCE REPORT (FH)

- Balances are: checking: \$1,078.83 plus pending deposit of \$11,750 not yet posted from current collected common fees; Money Market: \$86501.71; Total funds available: \$87,580.54
- Outstanding bills to be paid total \$11,788.01
- \$2,000 has been moved from MM current operating account; being paid back once common fee deposit is posted.

Snow plowing

Landscaping

Community Boundaries

- We updated the HOs in an email of our progress on this issue. To date, we received many positive responses from HOs to our proposed solution of a drainage easement to be drawn up that protects our interests, acquits us of any current or future liability, adds us as additional insured, registers this easement with the town and on his deed all at his cost rather than sale of encroachment area.

New Business

Recycling Scavengers

- It was reported that a person was going through the garbage and recycle bins
- The HO contacted the Public Works department and they had no solutions; the HO then contacted the police and they, too, offered no solution
- WL position is that they are trespassing on private property but there may be no relief from the police. You should call Police each time it happens. Their response, however, may be longer than the scavenger is present. As calls mount up, they may do something about this.
- Solutions from the board were offered:
 - Do not put any recyclables that have a deposit on them into your bins. Collect them separately and then donate to other organizations. The Boy Scouts at Long Hill Ave and Rocky Rest Rd at the church are there 1st Saturday of the month and accept recyclables. They are very helpful in transferring from your car to their containers.
